PAGEANT RULES AND REGULATIONS

MISS FAUQUIER COUNTY FAIR is selected from residents, students, and employees in Fauquier County (or parent). The contestant selected as MISS FAUQUIER COUNTY FAIR (Miss FCF) will reign for one full year, beginning with her coronation and ending on predetermined day of the next fair. Miss FCF agrees not to compete at any other pageants during her reign, unless approved by FCF pageant directors. Miss FCF agrees to participate in events to which she is invited. In addition, she may schedule additional appearances with the knowledge and approval of the Pageant Director.

The following guidelines shall apply to participants in the Miss FCF competition, as set by the Miss Virginia Association of Fairs:

Contestant must be single, never married, without children, and never having been pregnant.

Contestant must be between the ages of 13-15 **on the date of the pageant.**

Contestant must be female who has always been female.

Contestant must possess strong moral character. She will not be allowed to compete if she has been convicted of a crime or has criminal charges pending against her (not including minor traffic violations). She will not be allowed to compete if she has engaged in any activity, which is characterized as dishonest, immoral, indecent, or in bad taste. This also includes any improper action on social media, in print, or via any electronic form of communication. Contestants must also be in good standing with their school.

Contestant must be a Virginia resident, and (Contestant or Parent) must be a resident, student, or employee of Fauquier County. Contestants can compete in the Miss FCF Pageant more than once. Cannot have been a previous Miss Virginia Association of Fairs.

Contestants may have been a previous Miss FCF, However must wait 2 years between winning and competing. (2017 can compete again in 2020)

Contestant and all accompanying pageant guests will conduct themselves in a proper, professional manner at ALL times. Any display of uncooperative or unsportsmanlike conduct will result in disqualification.

There will be a ZERO tolerance policy for BULLYING.

Contestant must be at every rehearsal in order to participate. All rehearsals are closed to the public unless announced otherwise by the FCF Pageant Director.

Contestant will compete in private interview, personality wear, civic engagement, evening gown, and onstage question.

Contestant must remain on stage until ALL awards are presented. Leaving the stage before dismissal by emcee or directors will result in disqualification of any awards, and any future Fauquier County Fair Pageants.

The decisions of the judges are final.

The Decisions of directors and Fair board members are Final.

The first runner-up must be willing to assume all duties in the event that the winner is unable or unwilling to fulfill her reign.

Winners will agree to attend at least 12 mandatory and/or approved events, appearances, parades, fundraisers, etc.

Winner of Miss FCF will be eligible to compete at Miss Virginia Association of Fairs 2021.

Except for signatures, all applications must be **TYPED** (not handwritten). ALL RESPONSES to application must be typed in 12pt Font. PLEASE do not change of size on anything pre-typed.

Contestants must submit an 8x10, Black and White HEADSHOT.

The Fauquier County Fair Pageant committee, reserves the right to deny applications and/or disqualify contestants with just cause. Notice of Denial will be sent Via Mail.

AREAS OF COMPETITION and CONTESTANT REQUIREMENTS

OPENING NUMBER The opening number will be a simple dance routine taught at rehearsals. Opening Number outfits will consist TEEN- White tops, MISS- Black tops, with jean skirts or shorts and cowboy boots. Opening number is NOT judged; however this is your first impression on the judging panel.

PERSONALITY WEAR Your personality wear will be modeled in a fast-paced modeling pattern, which will be taught at rehearsals. An outfit of your choice that best displays your personality is to be worn. Each contestant will present her *community engagement* speech while wearing this outfit. Please be tasteful, yet youthful when choosing this outfit, as it will be representative of you.

COMMUNITY ENGAGEMENT Contestants will be given up to one minute to introduce and speak about themselves and their platform. Note cards and props are not permitted.

EVENING GOWN COMPETITION Contestants will model their evening gown of choice in a modeling pattern taught at rehearsals.

ON STAGE QUESTION Two on-stage, unrehearsed question will be asked of each contestant.

SIDE AWARDS

PHOTOGENIC AWARD Each contestant is required to bring **ONE (8X10) BLACK AND WHITE HEADSHOT**. Photos will be judged and Miss Photogenic will be named. These photos will be on display during the Pageant. PHOTOS BECOME PROPERTY OF THE FAUQUIER COUNTY FAIR, AND WILL NOT BE RETURNED. Winners will Receive Sash.

*PHOTOS THAT ARE NOT THE CORRECT SIZE, COLOR, OR NOT A HEADSHOT WILL BE DISQUALIFIED FROM THE PHOTOGENIC COMPETITION.

MISS CONGENIALITY Will be voted on by contestants at Pre-Pageant Meeting, There Will be ONE Miss congeniality for both the Teen and Miss pageant. Winner will receive Sash.

SOCIAL MEDIA AWARD Contestants that wish to participate should make a tik tok, Instagram Reel, or a video up to one minute, Promoting the fair and/or pageant. These should be turned into the pageant director no later than Thursday July 15th. Details on submitting these will be discussed at rehearsal.

PAGEANT DAY The Dressing Area will be open to contestants starting at 5:00 pm A helper will be allowed to help you set up your designated area but must leave the dressing area in a timely manor due to space restrictions. You may come and go, as needed until 6:30pm, at this time the dressing room doors will be locked, contestants should be pageant ready and a pre-pageant meeting will be held. There WILL be multiple helpers to help with any dressing needs in the dressing areas. NO OUTSIDE HELP will be allowed; this is due to space restrictions. There are NO mirrors in the Dressing area so please come prepared, On Pageant Day you WILL find a labeled and taped off area with a large hook to hang all of your clothing.

please arrive before 5pm and plan for extra time due to the rodeo

CONTESTANT ORDER Contestants will randomly drawn prior to pageant.

ENTRY TO THE PAGEANT Contestants will receive one entry ticket for them selves to get into the fair on the day of the pageant.
